## **Policy for Night and Cross Country Flight Operations (All Courses)**

Night operations are those conducted between the time of one hour after sunset and one hour before sunrise.

For night VFR operations the student must possess a Private Pilot certificate at a minimum.

All flights MUST be scheduled to return to Ellington Field (KEFD) by midnight.

Cross country flights are flights greater than a 50nm straight line distance from the departure point.

Passengers are not permitted on any cross country training flight.

All landings will be made to a full stop, to either visit the FBO or taxi back for takeoff.

Cross country flights may only be made to airports on the approved cross country list at Flying Tigers.

Pilots will maintain a log showing actual "out" and "in" times for each destination and checkpoint utilized in the flight plan (training requirement).

Each flight will be briefed with an instructor before flight, and de-briefed after the flight.

#### **RELEASE AND WAIVER OF LIABILITY**

#### ASSUMPTION OF RISK AND INDEMNITY AGREEMENT

IN CONSIDERATION of being permitted to enroll in a course of flight instruction provided by Flying Tigers Flight School, Itd (the "Student"), for himself/herself, his/her personal representatives, assigns heirs and next of kin:

- 1. Acknowledges, agrees and represents that the STUDENT has been explicitly advised of the potential risk and hazards involved in a course of flight instruction and general aviation flying in particular and has been fully and completely advised prior to executing this agreement that a course of flight instruction and a flight training program and any other form of flight related activity incidental to the course of flight instruction and general aviation flying involves a high degree of risk and the possibility of property damage and serious personal injury and hazards t o the STUDENT and others, including but not limited to the possibility of death, which is inherent in the aviation industry inclusive of flight training, related activity, or flying in general having been fully informed of these hazards and risks. Including the possibility of death and fully and completely comprehending and understanding the same. The student still desires permission to commence a course of flight instruction and requests Flying Tigers, Itd provide the student with a training flight program, or engage in general aviation flying using Flying Tigers' asserts.
- 2. Further acknowledges it is the purpose of this release waiver of liability, assumption of risk and indemnity agreement to release Flying tigers, it's directors, officers shareholders, employees, agents, representatives, successors and assigns any owner or owners of aircraft leased or operated by or on behalf of Flying Tigers from any and all liability for all personal injuries. Including death, property damage that may occur during the course of flight instruction or any other related activity and to assume the risks of the above related flight activities.
- In order to induce Flying Tigers to provide flight training. DOES HEREBY (1) ASSUME FULL RESPONSIBILITY FOR ANY RISK OF BODÍLY INJURY. DEATH OR PROPERTY DAMAGE ATTENDANT WITH ANY FLIGHT TRAINING FLIGHT RELATED ACTIVITY OR FLYING IN GENERAL WHETHER CAUSED BY THE NEGLIGENCE OF THOSE IDENTIFIED HERIN OR OTHERWISE, (2) FOREVER RELEASE FLYING TIGERS, it's directors, officers shareholders, employees, agents, representatives, successors and assigns any owner or owners of aircraft leased or operated by or on behalf of Flying Tigers from and against any and all causes of actions, claims, rights or demands in law or in equity, which the STUDENT, his/her heirs, relatives, executors, administrators and assigns can or might have as a result of any loss, damages, expenses and personal injury, death or property damage which the STUDENT or any person may suffer or sustain, whether caused by the NEGLIGENCE OF THOSE IDENTIFIED HERIN OR OTHERWISE, and (3) AGREE TO IDENTIFY AND HOLD HARMLESS FLYING TIGERS, its directors, officers, shareholders, employees, agents, representatives, successors or assigns and any owner of owners of aircraft leased or operated by or on behalf of Flying Tigers from and against any and all claims damages, losses and expenses, suits and judgments in law or in equity, including attorney fees and disbursements, however caused, including but not limited to those for property damage, bodily injury including death arising out of or in connection with any and all flight performance or non performance, breach or alleged breach of any and all flight training flying in general, use and/or maintenance of any aircraft, flight related activities. any airport conditions and/or the performance or non performance breach or alleged breach of any representations or obligations, or the negligence of the parties identified herein. Log on to FlightSchedulePro.com with your account information to beginning booking flights! In order to keep the schedule open for as many people as possible please book all flights and instructors for periods of 2.5 hours. Username: Password: If you forget or lose your login information, contact Flying Tigers and someone will be able to help you. **Cancellation Policy** If you decide to make a cancellation, do so at least 24 hours prior to your scheduled flight. If you are late please contact your instructor directly. If not contacted, and after 15 minutes, the instructor and airplane will be available for someone else. After 30 Minutes have passes and you have not arrived for a scheduled flight, the full instructor fee for your reservation AND one hour flight time for any scheduled aircraft will be charged to your credit card on account. Until the fee has been reconciled, you will be on a no fly status. Rain-out Policy If weather or airplane issues cause a flight cancellation, students are still expected to show up to

complete required ground school lessons or to utilize the flight simulator for their lesson. This policy

may be waived when all ground training lessons have been completed.
